

APPLICATION FOR NGA FALL 2009 MEET KENNEL SPACE

As a recipient of a kennel in two of the last three meets, you are eligible for a kennel at the upcoming NGA Fall Meet (Oct. 12-17, 2009). This will entitle you to one of the 47 NGA kennels from Sept. 28-Oct. 18. (Kennels will not be available for rent to haulers or other persons traveling through town during that period.) Rent any time prior to Sept. 28 or after Oct. 18 will be 50 cents per dog per day, for those receiving a kennel.

The following kennels will be available for the Meet at the following rates:

- Ten 12-crate kennels. Pre-deposit \$115 (\$60 of which is refundable)
- Seven 18-crate kennels. Pre-deposit \$140 (\$60 of which is refundable)
- Twenty-three 24-crate kennels. Pre-deposit \$165 (\$60 of which is refundable)
- Seven 28-crate kennels. Pre-deposit \$165 (\$60 of which is refundable)

To remain eligible for this special offer, you **MUST** have this application and pre-deposit in by noon **July 17**. If there are more requests for a particular kennel-size than there are kennels available, a drawing will be held that day. Any remaining kennels will be drawn for on Aug. 17, 2009.

RENTERS OBLIGATION. Renters must notify NGA of any cancellations by Sept. 24 in order to qualify for full refund. Renters are obligated to immediately notify NGA of any cancellations after that date, so kennels may be made available to others. Renters are obligated to ensure kennels are clean and equipment is accounted for at time of departure to qualify for their refund. Only properly vaccinated (certified) Greyhounds competing in the Track Stakes or that are in the Auction should be kenneled on the grounds during the Sept. 28-Oct. 18 period. Failure to comply may result in a fine levied by the Board and/or disqualification from future drawings. Renters also agree to all terms of NGA's rental hold-harmless agreement.

This would entitle you to one of the NGA kennels from Sept. 28-Oct. 18. (Kennels will not be available for rent to haulers or other persons traveling through town during that period.) Rent any time prior to Sept. 28 or after Oct. 18 will be 50 cents per dog per day, for those receiving a kennel.

A limited number of kennels will be available for the Meet at the following rates:

- 12-crate kennels. Pre-deposit \$115 (\$60 of which is refundable)
- 18-crate kennels. Pre-deposit \$140 (\$60 of which is refundable)
- 24-crate kennels. Pre-deposit \$165 (\$60 of which is refundable)

To be eligible for the drawing, you MUST have this application and pre-deposit in by noon **Aug. 17, 2009.**
