

APPLICATION FOR NGA MEET KENNEL SPACE
NGA Fall Meet: Oct. 10-15

Any member planning to compete in the NGA Track Stakes and/or Auction may apply for kennel facilities on the NGA grounds by submitting the full rate (which includes a refundable deposit, refunded upon passage of kennel inspection after departure). Application and payment in full must be received before Aug. 15, 2005.

There are now 994 kennel crates available on NGA grounds; but if more applications are received than there are kennels, names will be drawn at random. Monies will be returned in full to persons whose names are not drawn. If not all kennels are requested, those remaining will be available on a first-pay, first-served basis. Sorry, only one kennel per person.

Drawing a kennel will entitle the member to kennel access any time from Sept. 26 - Oct. 16(Therefore kennels will not be available for rent to haulers or other persons traveling through town during that period.) Rent any time prior to Sept. 26 - Oct. 16 will be 50 cents per Greyhound, per day. The following kennels will be available for the Meet at the following rates:

- Ten 12-crate kennels...Pre-deposit: \$80 (\$25 of which is refundable)
- Seven 18-crate kennels...Pre deposit: \$110 (\$30 of which is refundable)
- Twenty-three 24-crate kennels...Pre-deposit: \$140 (\$35 of which is refundable)
- Seven 28-crate kennels...Pre deposit: \$140 (\$35 of which is refundable)

To be eligible for the kennel drawing, you MUST have your full application and pre-deposit in by noon Aug. 16. The drawing is held on that day to allow those not receiving kennels plenty of time to make other arrangements for the Meet.

RENTERS OBLIGATION. Renters must notify NGA of any cancellations by Sept. 22 in order to qualify for full refund. Renters are obligated to immediately notify NGA of any cancellations after that date, so kennels may be made available to others. Renters are obligated to ensure kennels are clean and equipment is accounted for at time of departure to qualify for their refund. Only properly vaccinated (certified) Greyhounds competing in the Track Stakes or that are in the Auction should be kenneled on the grounds during the Sept. 26 - Oct. 16 period. Failure to comply may result in a fine levied by the Board. Renters also agree to all terms of NGA's rental hold-harmless agreement
